Actual Procedure: 8/20/2021: Drill 17.5 inch surface hole to 1137 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1124 ft. Pump 40 bbls gel with CTB-15, followed by 400 sks of 13.5 ppg lead cmt, 480 sks of 14.8 ppg tail cmt. Drop plug and displace with 167 bbls of brine. 167 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 8/21/2021: Drill 12.25 inch first intermediate hole to 3630 ft. 8/22/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 3614 ft. Pump 20 bbls chem wash, 20 bbls fresh water, followed by 794 sks of 12.8 ppg lead cmt, 404 sks of 14.8 ppg tail cmt. Drop plug and displace with 271 bbls of cut brine. 90 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 8/23/2021: Drill 8.75 inch second intermediate hole to 11218 ft. 8/27/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11144 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 793 sks of 11.5 lead cmt, 164 sks of 13.2 ppg tail cmt. Drop plug and displace with 509 bbls of active. 20 bbls of cement to surface. Pressure test casing to 2500 PSI for 30 minutes, good test.
