Actual Procedure: 8/30/2021: Drill 12.25 inch first intermediate hole to 5295 ft. 9/1/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5280 ft. Pump 20 bbls chem wash, 20 bbls spacer, followed by 1158 sks of 11.5 ppg lead cmt, 415 sks of 14.8 ppg tail cmt. Drop plug and displace with 397 bbls of freshwater. 40 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 9/2/2021: Drill 8.75 inch second intermediate hole to 11447 ft. 9/6/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11348 ft. Pump 20 bbls chem wash, 20 bbls gelled water, followed by 399 sks of 10.5 lead cmt, 138 sks of 13.2 ppg tail cmt. Drop plug and displace with 519 bbls of water. 0 bbls of cement to surface. 10 bbls of spacer to surface. EST TOC at 3482 ft. Pressure test casing to 2500 for 30 minutes, good test.
