Actual Procedure: 8/29/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 5458 ft. 8/30/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5444 ft. Pump 20 bbls chem wash, 20 bbls spacer, followed by 1158 sks of 11.5 ppg lead cmt, 415 sks of 14.8 ppg tail cmt. Drop plug and displace with 410 bbls of freshwater. 5 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 9/1/2021: Drill 8.75 inch second intermediate hole to 11152 ft. 9/3/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11051 ft. Pump 20 bbls chem wash, 20 bbls gelled water, followed by 273 sks of 10.5 lead cmt, 144 sks of 13.2 ppg tail cmt. Drop plug and displace with 505 bbls of fresh water. 0 bbls of cement to surface. EST TOC at 4000 ft. Pressure test casing to 2450 for 30 minutes, good test.
