Actual Procedure: 8/22/2021: Drill 17.5 inch surface hole to 1316 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1302 ft. Pump 20 bbls freshwater, and 40 bbls gel with CTB-15, followed by 785 sks of 13.5 ppg lead cmt, 345 sks of 14.8 ppg tail cmt. Drop plug and displace with 190 bbls of brine. 190 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 8/24/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 5453 ft. 8/25/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5438 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 1155 sks of 11.5 ppg lead cmt, 419 sks of 14.8 ppg tail cmt. Drop plug and displace with 409 bbls of freshwater. 60 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 8/26/2021: Drill 8.75 inch second intermediate hole to 11630 ft. 8/29/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11533 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 473 sks of 10.5 lead cmt, 138 sks of 13.2 ppg tail cmt. Drop plug and displace with 527 bbls of cut freshwater. 90 bbls of cement to surface. Pressure test casing to 2550 PSI for 30 minutes, good test.
