KOP 3851' MD. TOH. 10/15/21: RU casing crew. Run 115 jts of 7 inch 26# J55 LTC casing. Set from surface to 5065' MD. Float collar at 5019' MD. RU cement crew. 5000 psi test on lines. Test good. Cement with 55% excess on both lead & tail. Lead cement: 135 bbls (328 sx) 12.3 ppg, 2.32 yield, 13.2 gps. Tail cement: 66 bbls (250 sx) 13.5 ppg, 2.32 yield, 7.23 gps. Bump plug 1330 psi, pressure up to 1930 psi & hold for 5 min. 62 bbls good cement back to surface. TOC: surface BOC: 5065'. No regulatory agencies onsite to witness.
