Run 10.75 inch 45.5 lb J55 surface casing to 1260 ft. Pump 40 bbls gel spacer, followed by 450 sks of 13.5 ppg lead cmt, 200 sks of 14.0 ppg tail cmt. Drop plug and displace with 117 bbls of brine and 20 bbls fresh water. 85 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 10/30/2021 Spudded well.
