11/2/21 – MIRU and NU BOP. Set a CIBP at 2480'. Perforated at 2470'. Attempted to establish rate through perfs, held 500 psi. Spotted 25 sx Class "C" cement on top of CIBP to 2244', tagged.

11/3/21 – Perforated at 1068'. Attempted to establish rate through perfs, held 500 psi. Spotted a 30 sx Class "C" cement plug from 1122'-826', tagged. Perforated at 150'. Established rate through perfs, held 400 psi. Squeezed with 60 sx Class "C" cement from 150' and circulated up to surface.

11/4/21 - Cut off wellhead and installed above ground dry hole marker. Cut off anchors and cleaned location. **WELL IS PLUGGED AND ABANDONED.**
