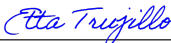

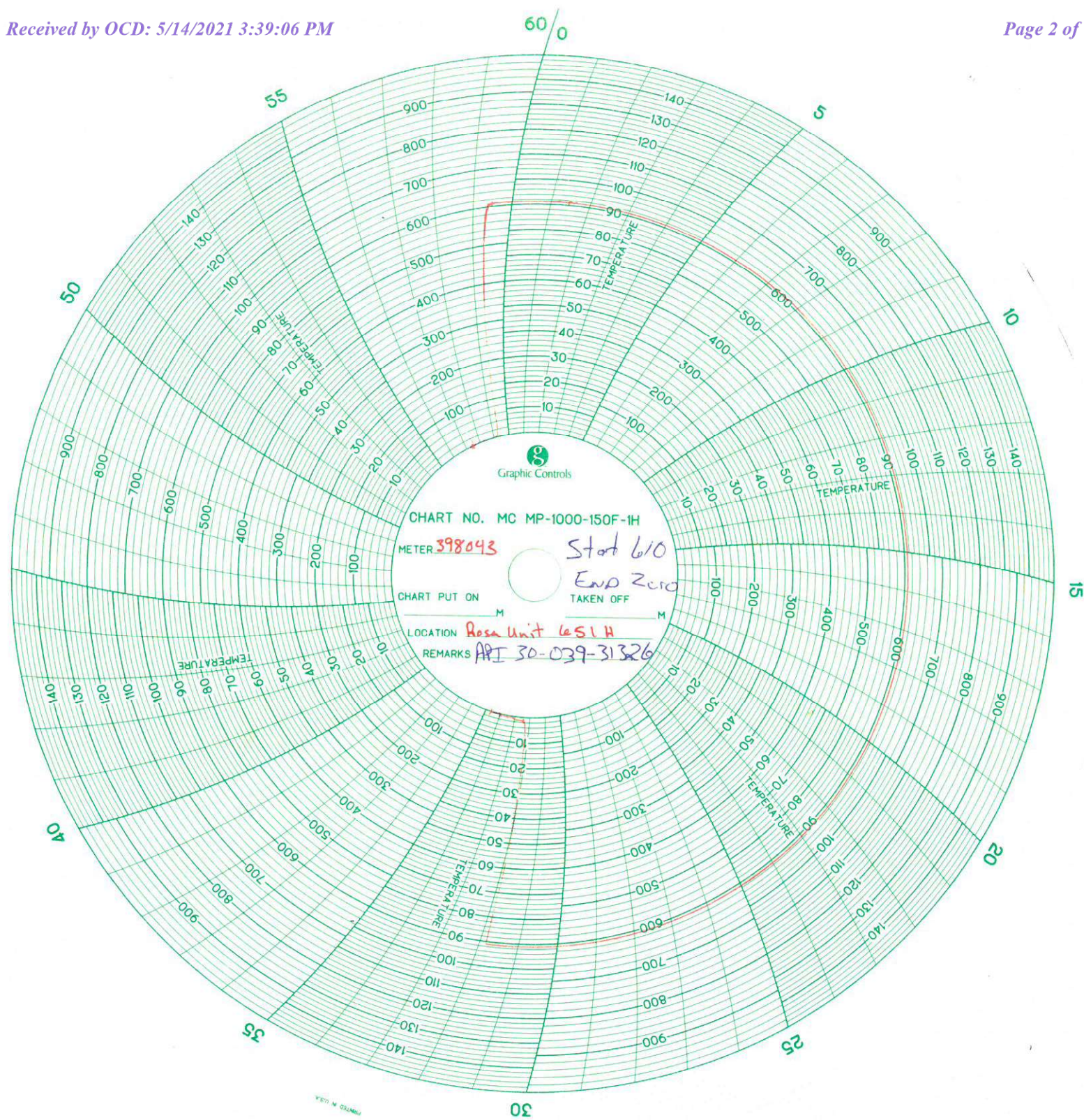

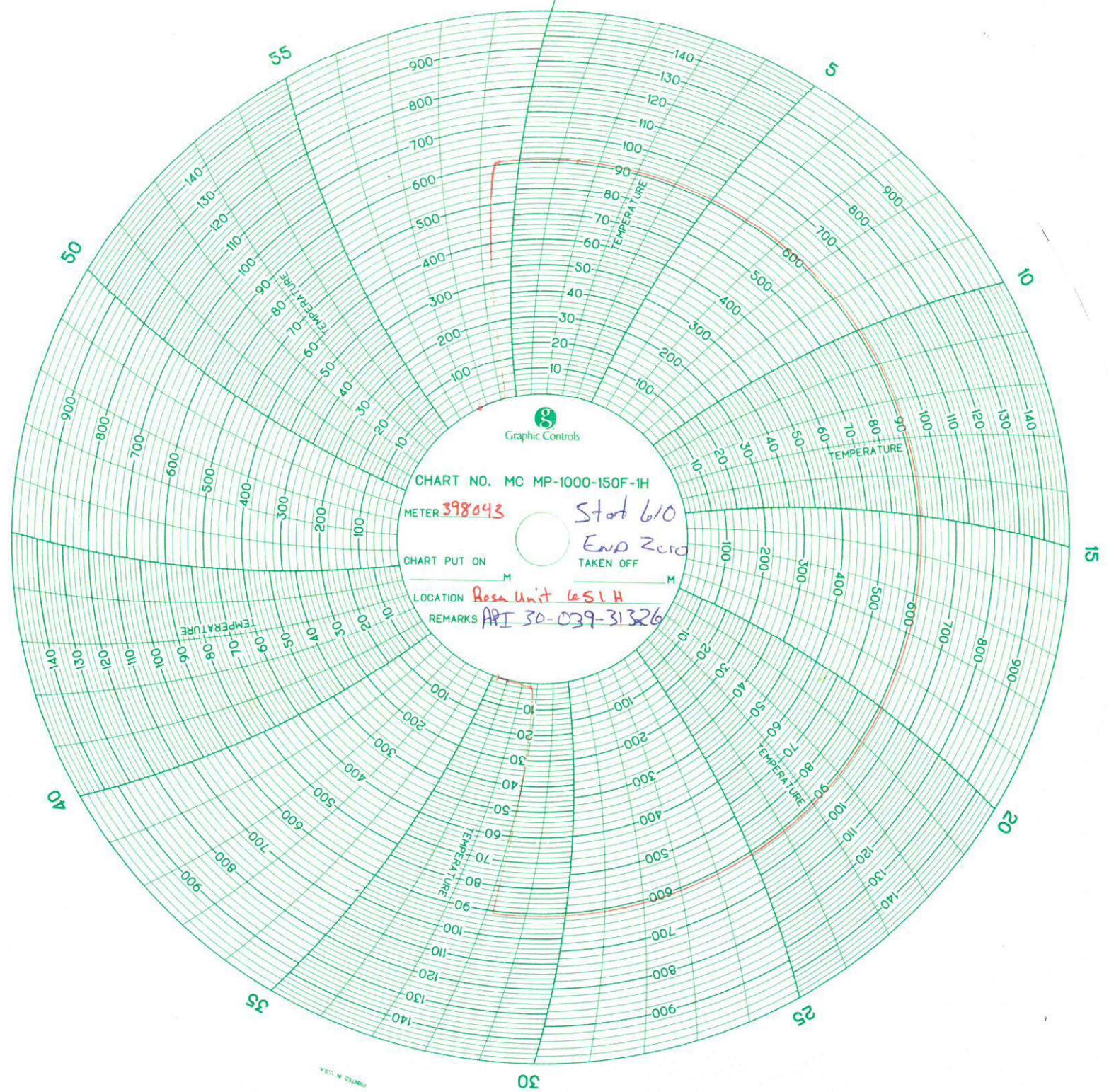

Wellbore Schematic

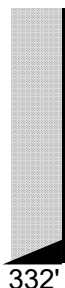

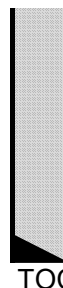
