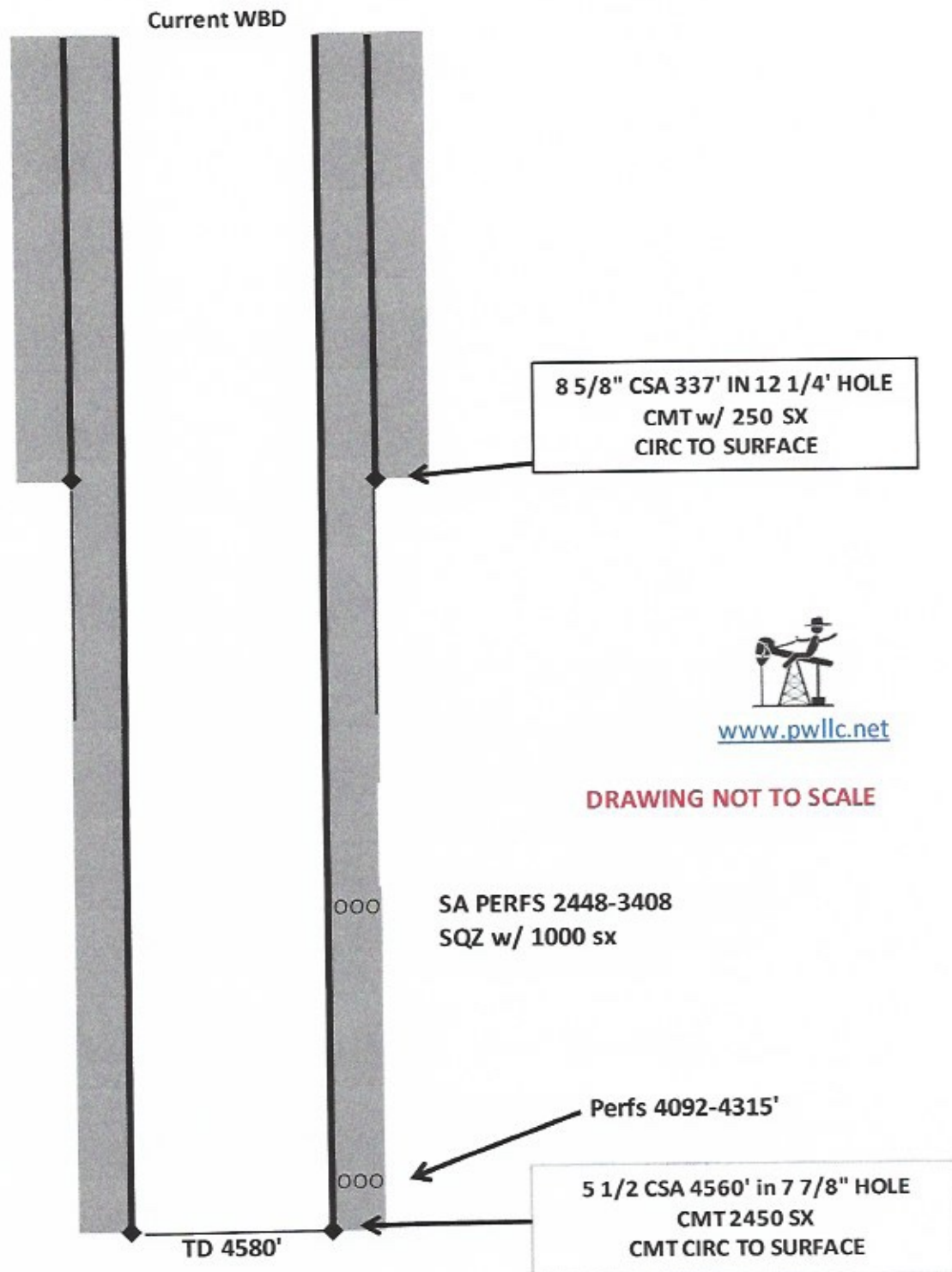

- 2 PRESSURE TEST CASING, SPOT 25 SX CEMENT 4045-3845
- 3 WOC AND TAG CMT PLUG
- 4 SPOT 25 SX CMT @ 2600-2400 (GRBG-SA)
- 5 SPOT 25 SX CMT @ 1000-800'. WOC AND TAG (BASE OF SALT)
- 6 SPOT 90 SX CMT @ 475'-SURFACE (TOP SALT & 8 5/8"SHOE)
- 7 CUT OFF WELL HEAD, VERIFY CMT TO SURFACE
- 8 WELD ON BELOW GROUND DRY HOLE MARKER



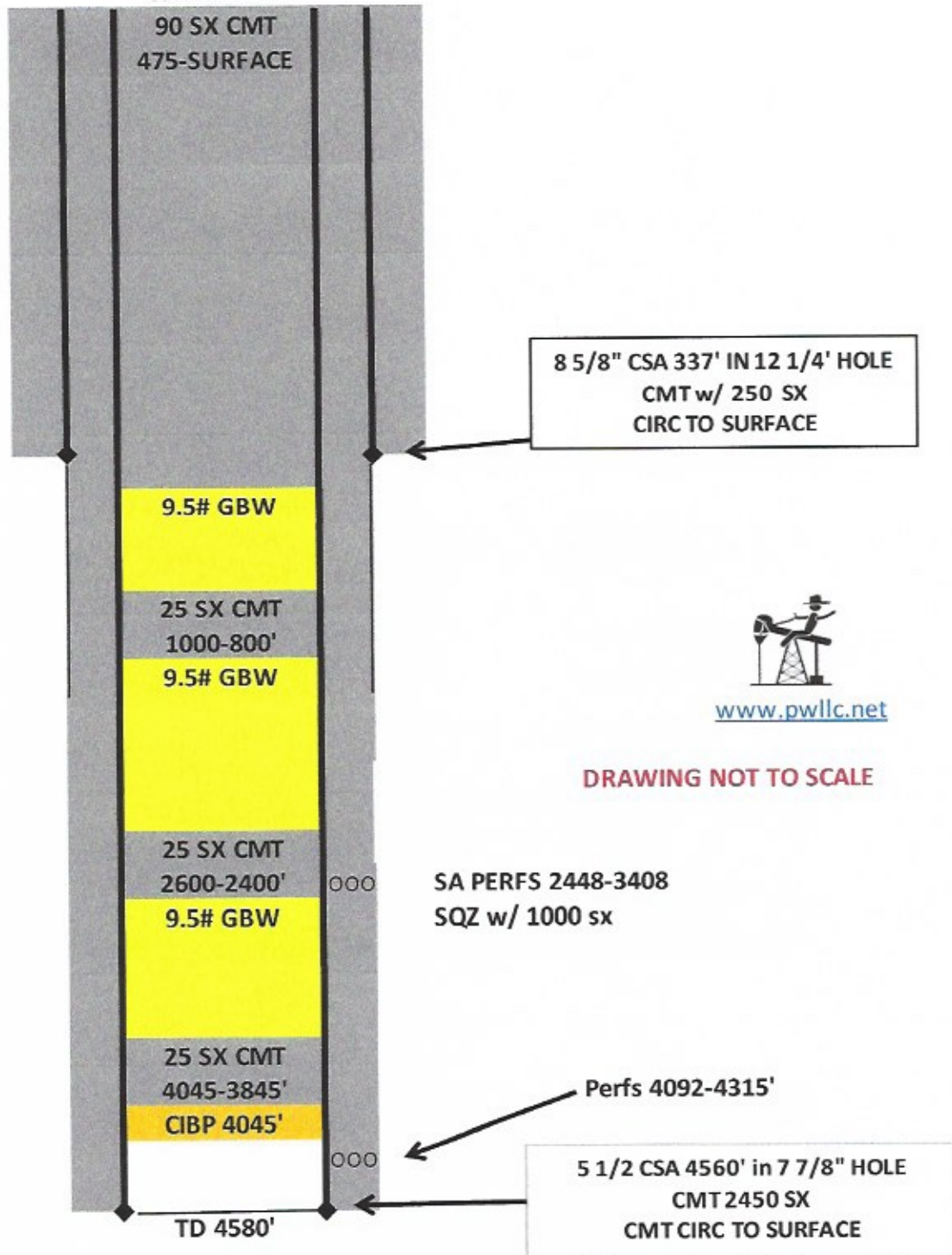
