Actual Procedure: 10/3/2021: Drill 17.5 inch surface hole to 630 ft. Run 13.375 inch 54.5 lb J55 surface casing to 620 ft. Pump 40 bbls gel spacer, followed by 565 sks of 13.5 ppg lead cmt, 255 sks of 14.8 ppg tail cmt. Drop plug and displace with 90 bbls of freshwater. 0 bbls of cement returned back to surface. Pump 4 bbls at 1 bpm until returns to surface. Witnessed by BLM and Tap Rock personnel. Pressure test casing to 1500 PSI for 30 minutes, good test. 10/5/2021: Test BOPS. Drill 12.25 inch intermediate hole to 3090 ft. 10/6/2021: Run 9.625 inch 40 lb J55 intermediate casing to 3070 ft. Pump 40 bbls gel spacer, followed by 625 sks of 12.8 ppg lead cmt, 255 sks of 14.8 ppg tail cmt. Drop plug and displace with 229 bbls of freshwater. 70 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
