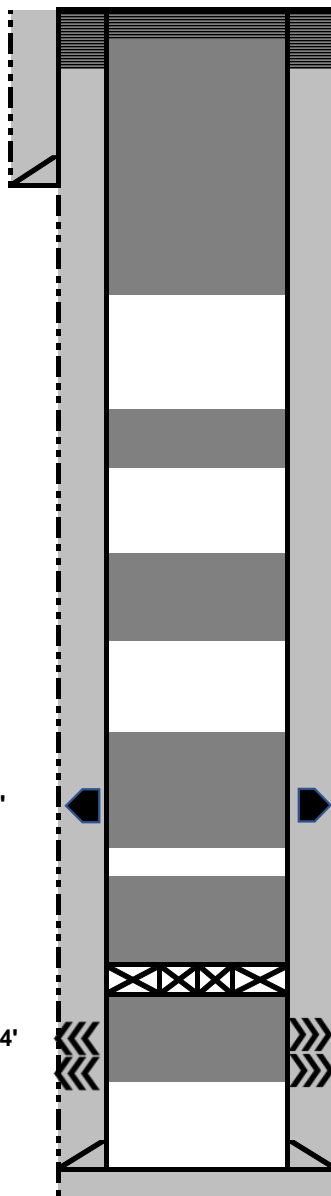

11-02-2021: Plug 4: Cliffhouse: Spot balanced plug of 46 sx cement from 2192' to 1797'.
