Icy 7 Fed 509H 30-025-47188

In order to service depletion from an offset operator, EOG prioritized development in the Wolfcamp formation delaying the development of the Bone Spring. The simultaneous development and production of the two formations would exceed infrastructure capacities potentially resulting in the need to flare gas and/or truck oil and water. Additionally, recent well results suggest that optimal development of this formation to harvest the most minerals and reduce waste will require supplemental permits.

EOGs goal is to spud this well by 1/23/23.
