11/3/21 – MIRU and NU BOP. RIH with GR/JB to 1550'. Set a CIBP at 1533'. Tested to 500 psi for 15 min, held good. ND BOP.
 12/13/21 – MIRU and NU BOP to finishing plugging. Perforated at 1220'. Attempted to establish injection rate. Pressured up to 500 psi for 15 min, held good. Tagged CIBP at 1533'. Spotted 30 sx Class "C" cement on top of CIBP to 1098', tagged.
 12/14/21 – Perforated at 150'. Established injection rate. Squeezed with 80 sx Class "C" cement, pumped 60 sx and lost circulation, stopped pumping for 10 minutes, then continued to squeeze cement to surface. Visual cement to surface.
 12/22/21 – Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location. **WELL IS PLUGGED AND ABANDONED.**
