**Actual Procedure:** Avant Operating LLC wishes to report to report a change in the setting depth of the 9-5/8" intermediate casing on all Golden Tee 31 Federal Com wells from 5830' to 5600'. The depth of the Capital Reef for the wells on this pad id 5600' TVD. Wells on this pad are the Golden Tee 31 Federal Com wells 301H, 302H, 501H, and 502H. Currently drilling the intermediate casing on the Golden Tee Federal Com #302H, 30-025-49325. Began this operation 9/16/21. We will be through the Capitan Reef at this depth. Four (4) wells roughly 500' directly north of us all set their intermediate casing string at ~5,600'TVD for reference The shallower setting depth for the 9-5/8 casing at ~5,600'TVD has been established and proven by other Operators within a 1 mile radius of our surface hole locations. Any deeper than this proven depth would raise concerns for competent rock that would be able to support a proper cement job and successful casing set.
