# **DESCRIPTION OF WORK:**

9/8/21: Well was spud @10:30 AM. Drill 17-1/2" surface hole to 1,020'.

9/9/21: TD 17-1/2" surface hole @ 1906'.

**9/10/21**: Ran 13-3/8", 54.4#, J-55 surface csg. to 1891'. Shoe @ 1891' and float collar @ 1,845'. Cement lead, 825 sks., 1.9 yield, Poz 65 CLC; Tail w/260 sks., 1.35 yield, CLC. Full returns throughout job. Circulate to surface. 218 sxs returned to surface. Test casing to 1,500# for 30 minutes. Good test. RR @ 18:30 and go to #301H.

**9/15/21**: Test BOP. Test Bop's as follows: annular 250 psi low/ 3,500 psi high; upper & lower vbrs, blind rams, hcr, super chokes, blm line 250 psi low/5,000 psi high. 5 minutes low / 10 minutes high perform accumulator draw down test. #2 super choke would not test, Ironhorse tech on location @ 04:15, will retest against manual hcr after repairs and before drill out.

9/16/21: Drill 12-1/4" hole to 5,269'.

**9/17/21**: Notified BLM, Long Vo, Pet., requesting to change the permitted Intermediate casing setting depth from 5,830' to 5,600'+. Received verbal permission from Mr. Vo. Sent in Sundry of request, ID #2634821 for written approval.

**9/17/21:** TD 12-1/4" intermediate hole @ 5,635'. Ran 9-5/8 40#, J-55 intermediate csg., to 56,20'. Shoe @ 5,620', float collar @ 5,575' and DV tool @ 3,022'.

**9/18/21**: Cement lead 1,515 sxs, 1.84 yield, Poz 65 CLC; Tail w/360 sks., 1.27 yield, Poz 50 CLC. Spoke w/Mr. Thomas w/BLM @ 10:58 and 11:13 and received permission to continue operations. Pumped first stage cement job and did not return cement to surface. Followed up w/email on 9/18/21. Returned 17 bbls of spacer, calculated top of cement at 743' which is 1148' tie back in surface casing shoe set at 1,891'. Unable to open DV tool. Due to cement already being tied back into the previous string, safety concerns of perforating that high in the string and the fact the next hole section is the production hole, we intend to continue operations and to bring cement to surface on the production job.

**10/23/21**: Skid well from 301H to 302H. Drill out cement. Test casing to 1,500 psi for 30 minutes. Good test.

**10/24/21**: Drill 8-3/4" vertical hole to from 5,645 to KOP @ 9,375'.

**10/25/21 through 10/30/21**: Drill 8-3/4" curve section from 9,375 to 17,039'.

**10/31/21**: TD production hole @ 17,873. Notified Mila Hackford w/BLM of intent to run production casing and cement 10.31.21 @ 20:15.

**11/1/21**: Rig up casing equipment for 5-1/2" production csg.

**11/2/21**: Run 5-1/2", P-110 RY casing to landing point @ 17,858'. Pump lead 840 sxs, CLC, 3.39 yield. Tail w/2175 sxs, CLC 1.21 yield. Returned 233 sacks cement to surface. Back out & lay down landing joint; set pack off & pull test 50,000; test lower pack off seals to 5,000 psi/10 minutes, good test.

**11/3/21**: RR @ 06:00 hrs. Final drilling report. Golden Tee 31 Fed Com 4 well pad complete.

**12/08/21 through 12/20/21:** Move in and rig up frac crew. Total of 35 stages, plug, perf and frac. Perf 10,194' – 17,789'. Frac w/111,111 bbls. liquid and 9,999,999 lbs. of proppant. Well shut in pending drill out.
