Pumped 60 bbls Intraguard Star @ 11.0 ppg. **Pumped Lead Cement: 223.17 bbls (545 sx)** ASTM Type 3 at 12.4 ppg, 2.30 ft3/sk, 12.9 gal H2O/sk. **Pumped Tail Cement: 533.33 bbls (1950 sx)** Class G cement at 13.3 ppg, 1.54 ft3/sk, 7.41 gal H2O/sk. Dropped plug & began displacement. Displaced with 370 bbls with cement retarder in 1st 50 bbls. FCP at 1,425 psi and plug bumped at 2.0 bpm to 2,750 psi. Bled back 3.5 Bbls and floats held. Maintained returns throughout job. Calculated 73 bbls to surface and got **110 bbls of good cement to surface**. Top of Lead to surface and top of tail at 4,085 ft MD.
