11/11/21 - MIRU and NU BOP. Attempted to release packer and did not.

11/12/21 – Stacked out at 6387'. Top of packer supposed to be at 6372'. RIH with chemical cutter and cut tubing at 6355' and POOH.

11/16/21 – Tagged and caught fish at 6320', started jarring over string weight.

11/17/21 – POOH with tubing. End of packer at 8194'.

11/18/21 – RIH with bit and scraper and did not tag anything. Pressure tested to 1500 psi, held good.

11/19/21 – TIH open ended with tubing at 8176'. Rigged down.

12/21/21 – MIRU and NU BOP to continue plugging the well. RIH and set a CIBP at 8152'. Dump bail 3 sx Class H cement on top of CIBP to 8113' calc TOC.

12/22/21 – Tagged TOC 8112'. Set a CIBP at 6362', tagged. Wireline tag approved by Jim Amos with BLM-Carlsbad. Pressure tested to 500 psi, held good. Spotted 25 sx Class C cement on top of CIBP to 5994' calc TOC.

12/28/21 – Tagged TOC 5820', tag was high. Joe Salcido with BLM-Carlsbad witnessed and ok'd to tag with wireline due to high winds. Jim Amos was notified of high tag and he ok'd to proceed to next plug.

12/29/21 – Perforated at 5165'. Squeezed with 50 sx Class C cement from 5165'-5130', tagged. Pressure tested to 800 psi for 10 min, held good. Spotted a 25 sx Class C cement plug from 5130'-4762', tagged.

12/30/21 – Perforated at 4030'. Established injection rate. Squeezed with 40 sx Class C cement from 4030'-3870' calc TOC.

1/3/22 – Tagged TOC 3772'. Established rate through perf. Squeezed with 40 sx Class C cement from 1990'-1866' calc TOC.

1/4/22 – Tagged TOC 1801'. Perforated at 1087'. Established rate through perf. Squeezed with 120 sx Class C cement from 1087'-597' calc TOC.

1/5/22 – Tagged TOC 558'. Perforated at 250'. Established rate through perf. Squeezed with 70 sx Class C cement from 250' and circulated up to surface.

2/15/22- Cut off wellhead. Installed above ground dry hole marker as per BLM. Cover cellar and cut off anchors.
