1/19/22 - MIRU and NU BOP. Set a CIBP at 7428', tagged. Tested to 500 psi, held good. Terry Cartwright with BLM was on location and witnessed test. Spotted 30 sx Class C cement on top of CIBP to 7300'.

1/20/22 – Tagged TOC 7231'. Terry Cartwright with BLM witnessed tag and was good to proceed with plugging operations. Spotted a 27 sx Class C cement plug from 5890'-5730'. No tag required. Spotted a 27 sx Class C cement plug from 5350'-5190'. No tag required. Spotted a 25 sx Class C cement plug from 3680'-3530'. No tag required. Spotted a 25 sx Class C cement plug from 2120'-1970'. No tag required. Perforated at 1250'. Pressure tested to 550 psi, held good. Terry Cartwright witnessed test. Spotted a 40 sx Class C cement plug from 1300'-1055'.
