MIRU rig, pull tubing.

12-22-2021:

MIRU rig and equipment. SICP = 1200, BH = 0.

TIH to 6364' with scraper. TOOH. TIH with CR, set at 6364'. Pressure test casing to 700 psi, good test.

12-23-2021:

P&A Plug 1&2: Dakota perfs and Dakota formation top: TIH and pump Plug 1 of 17 sx through CR into Dakota perfs from 6464' to 6812'. Sting out and place Plug 2 of 14 sx above CR from 6364' to 6186'.

P&A Plug 3: Gallup formation top. Pull up to 5396', mix and pump balanced plug of 14 sx from 5396' to 5218'.

P&A Plug 4: Mancos formation top. Pull up to 4549', mix and pump balanced plug of 14 sx from 4549' to 4371'.

P&A Plug 5: Mesa Verde formation top. Pull up to 3650', mix and pump balanced plug of 14 sx from 3650' to 3472'.

P&A Plug 6: Chacra formation top. Pull up to 2953', mix and pump balanced plug of 14 sx from 2953' to 2775'.

P&A Plug 7: Pictured Cliffs, Fruitland, Kirtland and Ojo Alamo formation tops. Pull up to 2138', mix and pump balanced plug of 55 sx from 2138' to 1436'.

12-27-2021:

P&A Plug 8: Perf holes at 417'. Attempt to circulate to surface, could not. Obtained approval from NMOCD and BLM to set CR at 388' and pump outside plug. TIH and set CR at 388'. Mix and pump Plug 8 of 17 sx through CR and outside 4 1/2" casing from 417' to 317'. TOOH.

P&A Plug 9: TIH to 388', mix and pump 24 sx inside casing from 388' to surface. TOOH.

Cut off WH. TOC in 4 1/2" x 8 5/8" at surface. TOC in 4 1/2" casing at 40'.

Install P&A marker. Mix top off plug of 32 sx to top off 4 1/2" casing and cellar.



12-27-2021: Perf holes at 417', not able to circ to surface. NMOCD and BLM approve inside plug through CR. Set CR at 388'.

12-23-2021: Plug 7: Pictured Cliffs, Fruitland, Kirtland and Ojo Alamo: Mix and pump balanced plug of 55 sx from 2138' to 1436'.

We will eliminate the 6 ft. dry hole marker and use a permanent metal plate that will be installed at ground level, effective September 2019. The marker will contain the following information:

- Well Pad Lease Number
- Well Pad Location Name and Number
- Well Pad Legal Description, specifically Section, Township and Range
- Well Pad API Number
- Well Pad Plug Date
- Well Pad Operator Name
