1-21-2022:

TIH with CR, set CR at 4684'. PT casing, casing did not test.

P&A Plug 1&2: Gallup perfs and Gallup formation top: Mix and pump 25 sx cement under CR into Gallup perfs. Sting out of CR, place 25 sx cement above CR. WOC. Tagged Plug 2 at 4480'.

P&A Plug 3: Mancos formation top: TIH to 3742', mix and pump balanced plug of 20 sx from 3742'. WOC.

11-24-2022:

TIH, tagged Plug 3 at 3595'.

P&A Plug 4: Mesa Verde and Chacra formation tops: Pull up to 2210'. Mix and pump a balanced plug of 101 sx cement from 2210'. WOC. Tagged Plug 4 at 1323'.

Pressure test casing, good test.

P&A Plug 5: Pictured Cliffs formation top: Pull up to 1165'. Mix and pump balanced plug of 20 sx cement from 1165' to 993'.

P&A Plug 6: Fruitland, Kirtland and Ojo Alamo formation tops: Pull up to 847'. Mix and pump balanced plug of 106 sx cement from 8475' surface, good cement returns. TOOH, top off casing with Plug 7 of 12 sx.

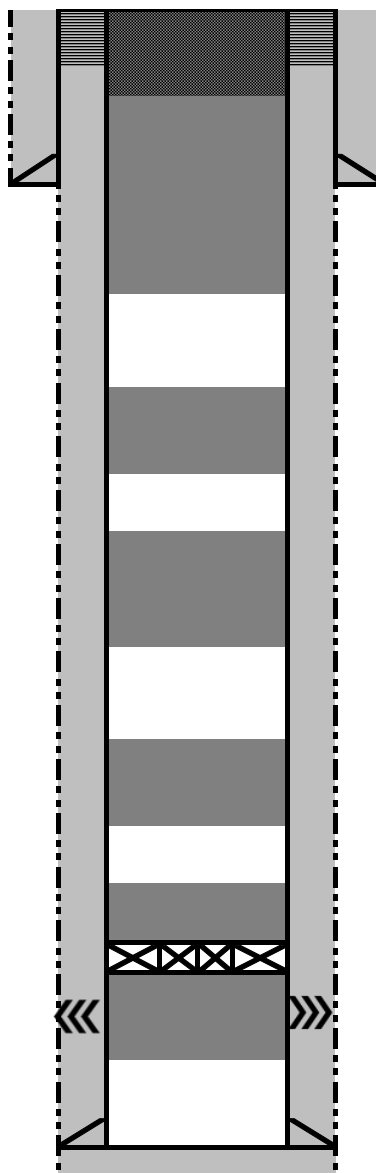
