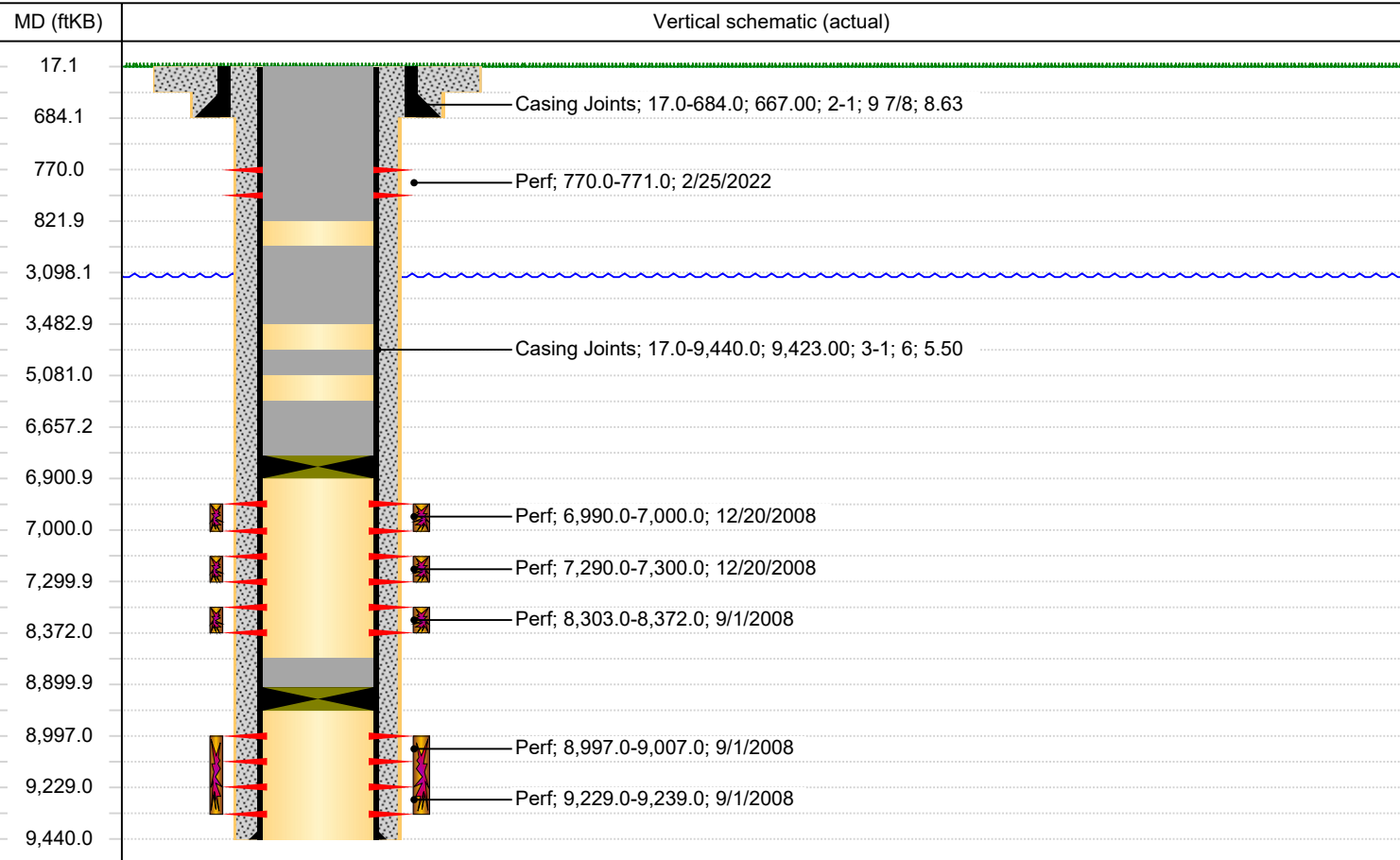


Wellbore Diagram - RRC
