**Procedure Description:** Titus Oil & Gas Production, LLC requests a two year extension for each of the subject APDs. Titus was unable to drill all of the wells in their initial approval term due to economic distress, and resulting commodity price challenges caused by the Covid-19 pandemic. By granting Titus a full two year extension, Titus will be provided i) time to establish key infrastructure that minimizes environmental impact, ii) the flexibility to sequence wells efficiently thus minimizing unnecessary reserve destruction, and iii) the ability to meet all contractual and lease obligations.
