3/14/22 – MIRU and NU BOP. RIH with sinker bars and tag sand on RBP at 4503'. George Barta with BLM-Carlsbad on location.

3/15/22 – Tagged sand on RBP at 4485'. George Barta with BLM on location to witness tag. Pressured up to 500 psi, held good. Spotted a 25 sx Class C cement plug from 4479'-4226' calc TOC. Spotted a 25 sx Class C cement plug from 3643'-3390' calc TOC. Perforated at 1630'. Pressured up to 500 psi, fell to 200 psi in 1 minute. No injection. Spotted a 35 sx Class C cement plug from 1692'-1450', tagged. George Barta with BLM said to spot another 25 sx Class C cement and was on location for all work done.

3/16/22 – Spotted 25 sx Class C cement from 1445'-1192' calc TOC. No tag required. Perforated at 450'. Pressured up to 600 psi. Pumped down 5-1/2" casing established circulation out 9-5/8" casing. Pumped 140 sx Class C cement at 450' and circulated up to surface. George Barta with BLM-Carlsbad on location to witness cement to surface.

3/23/22 - Cut off wellhead. Installed above ground dry hole marker as per BLM. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
