Pumped Tail Cement: 403.30 bbls (1448 sx) Class G Cement at 13.3 ppg, 1.56 ft<sup>3</sup>/sk, 7.7 gal H<sub>2</sub>O/sk. Washed lines, dropped plug & began displacement. 
