Actual Procedure: 7/31/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 3636 ft. 8/1/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 3583 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 693 sks of 12.8 ppg lead cmt, 337 sks of 14.8 ppg tail cmt. Drop plug and displace with 271 bbls of freshwater. 65 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 8/2/2021: Drill 8.75 inch second intermediate hole to 10762 ft. 8/6/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 10688 ft. Pump 20 bbls mud push, followed by 673 sks of 11.5 lead cmt, 138 sks of 13.2 ppg tail cmt. Drop plug and displace with 330 bbls of cut brine. 8 bbls of cement to surface. 30 bbls of mud push to surface. Est TOC at 3185 ft. Pressure test casing to 2350 for 30 minutes, good test.
