Cemented 13-3/8" casing as follows; pre-flushed lines with water, tested lines to 4,000psi, mixed & pumped 40 bbls fresh water spacer with dye followed by 40 bbls mud push @ 12 ppg, followed by 250 bbls lead @ 13.5 ppg (812 sks), followed by 99 bbls tail @ 14.8 ppg (418 sks).
