Actual Procedure: Franklin Mountain Energy, LLC (FME), Operator of the above captioned well, respectfully submits the below drilling operations notice: The Beauty Queen Fed Com 604H was spud utilizing surface rig, Transcend #4 on 2/28/2021 at 13:00 hrs. Drilled 17-1/2" hole to 1308' TD. Condition hole. RIH w/ 13-3/8" 54.5# J-55 BHC surface casing as follows; float shoe, 1 joint of casing, float collar followed by 30 joints of 13-3/8", btc thread to 1,308' (kb) 1,301' (gl). centralized joint 1, 3 & every 3rd joint to surface. Cemented 13-3/8" casing as follows; pre-flushed lines with water, tested lines to 2,000psi, mixed & pumped 40 bbls fresh water spacer with dye followed by 40 bbls mud push @ 12 ppg, followed by 177 bbls lead @ 13.5 ppg (842 sks), followed by 99 bbls tail @ 14.8 ppg (418 sks). Stopped pumping. Dropped plug. Displaced plug with 194.2 bbls water. Bumped plug with 1100 psi ,500 psi over fcp. Held pressure for 5 mins, bled back 1 bbl. Floats held. 100 bbls clean cement returned to surface. Good Cement. Release surface rig 3/1/2021 @ 23:59 hrs. Operations suspended between the completion of the surface section and move-in of the rig capable of reaching TD.
