Actual Procedure: Franklin Mountain Energy, LLC (FME), Operator of the above captioned well, respectfully submits the below drilling operations notice: Drilled 2nd intermediate 8.75" hole and land curve at 12,220' TD. Condition hole. RIH w/ 7.625" 29.7 lb/ft, HCP-110 intermediate casing as follows: 1 float shoe - 2.55', 1-jt 48.28', 1-float collar 2.44', 283-jts (12,110.49'). Landed @ 12,196.88' KB. Cemented 7.625" casing as follows: fill lines & pressure test to 4,000psi. - ok. Mix and pump 40 bbls mud push @ 9.00 ppg, mix & pump lead cement 193 bbls (344 sxs) @ 9.08 ppg, mix & pump 76 bbls (321 sxs) tail cement @ 14.8 ppg. Shut down and drop plug. Displace plug with 558 bbls water. Plug bumped on calculated displacement (fcp = 2400 psi) with 500 psi over final circulating pressure. Held pressure on floats for 5 min. Bled back 4 bbls. Floats held. Received lead returns to surface. Good cement.
