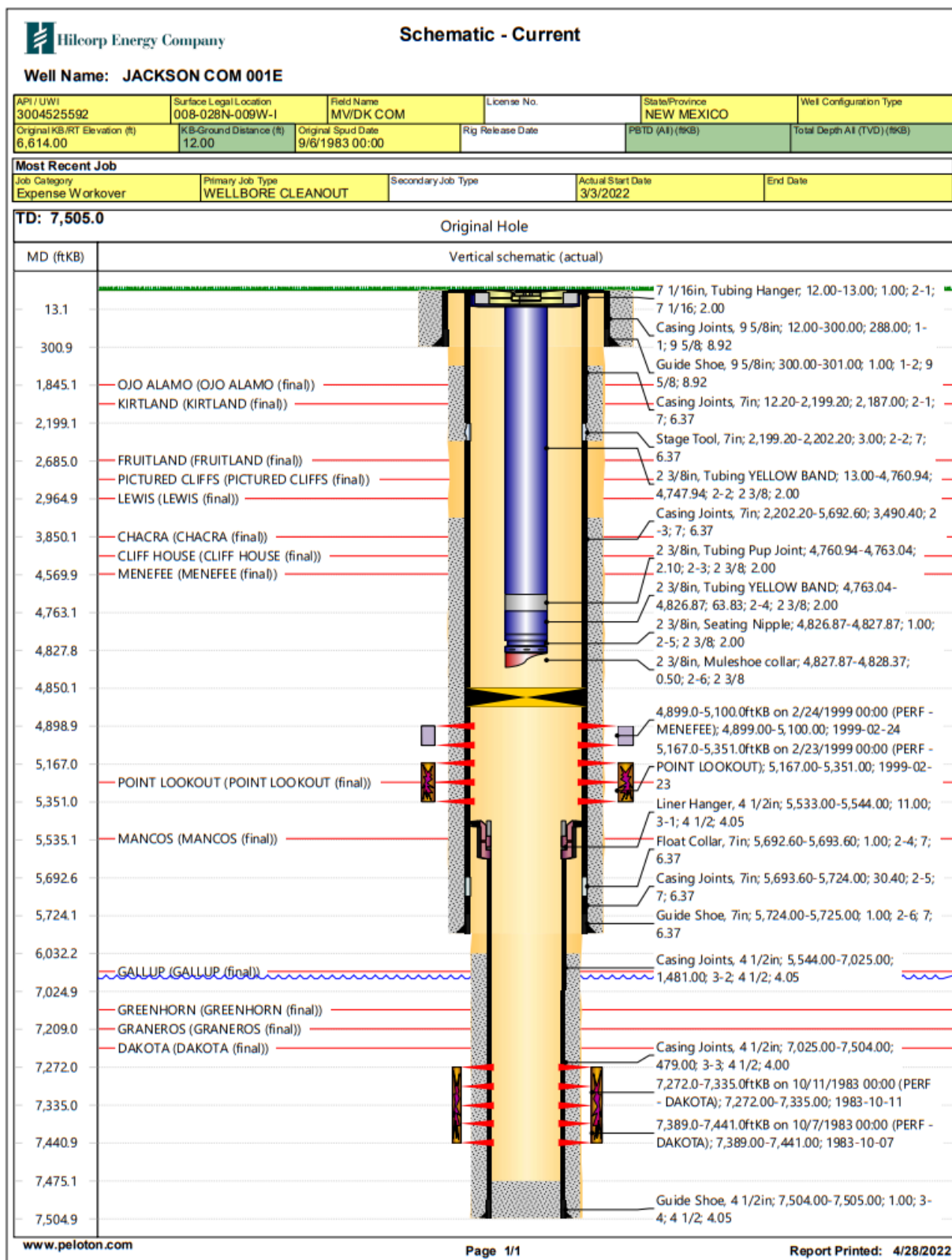
Casing Repair - NOI

Jackson Com 1E

API # - 3004525592

Procedure:

1. Test anchors if not using a base beam. Comply with all NMOCD, BLM, and HEC safety regulations. MIRU and conduct safety meeting for all personnel on location.
2. Record casing, tubing, and bradenhead pressures. Remove existing piping on casing valve. RU blow lines from casing valves and begin BD casing pressure. Well currently has a retrievable bridge plug set in hole so there should be 0 psi on the well.
3. RU WL and run a CBL from 4850' to surface.
4. ND wellhead and NU BOP. Function test BOP. RU floor and 2 3/8" handling tools.
5. Unset RBP and TOO H w/ 2-3/8" tubing inspecting each joint (4828'). LD RBP.
6. TIH w/ composite bridge plug and set at 4000'.
7. TOO H w/ 2-3/8". PU +/- 250' of 7" expandable liner in order to cover the compromised interval from 416' to 570' with 1 jt. of excess above the top hole and 2 jts. of excess below the bottom hole. Set liner from roughly 380' to 630' (subject to minor changes based on actual joint footage).
8. Load and roll the hole w/ fresh water and PT casing.
9. PU bit and TIH to drill out CBP at 4000'. TOO H and LD bit.
10. PU BHA and TIH w/ 7400' of 2-3/8" production tubing and establish circulation. CO well to bottom. Pump off expendable check and PT tubing. Land tubing.
11. RD floor. ND BOP and NU WH. RD unit. Prep for rig move.

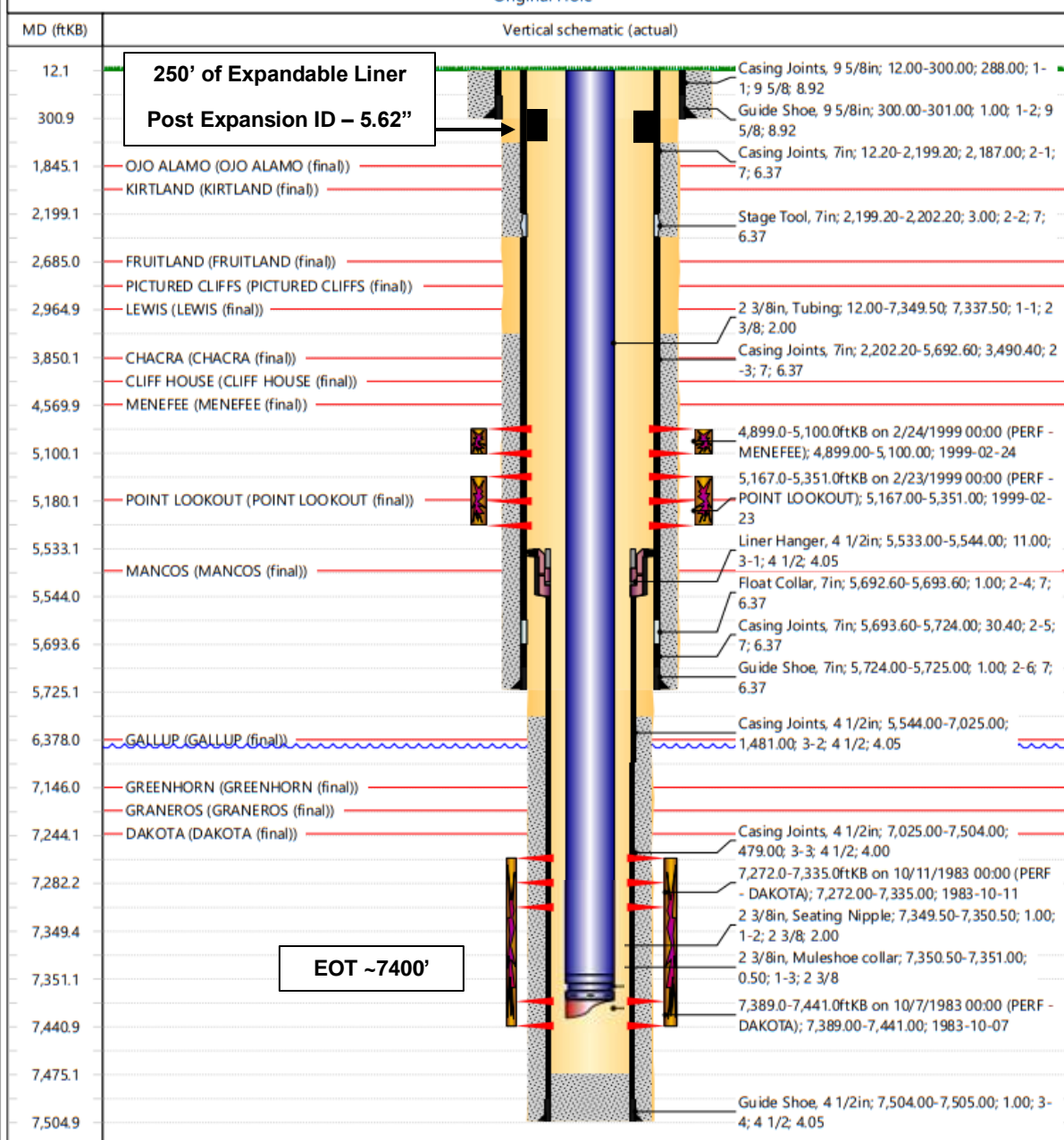
