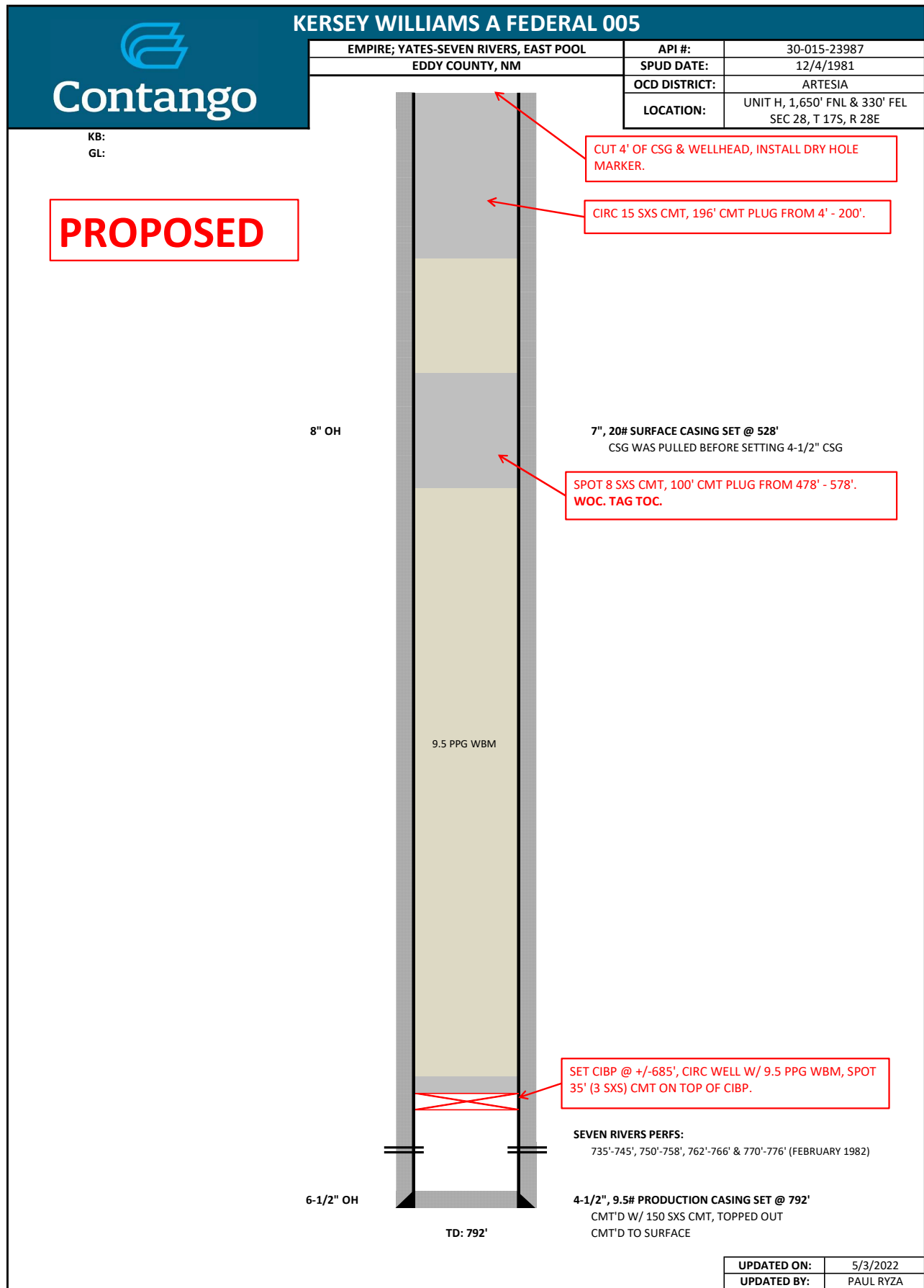

### Description of Procedure:

1. Set CIBP @ 685', circ well w/ water-based mud, pressure test csg, spot 35' (3 sxs) cmt on top of CIBP.
2. Spot 8 sxs cmt from 578' - 478', WOC & tag TOC.
3. Circ 15 sxs cmt from 200' to surface.
4. Cut off wellhead, verify cmt to surface, weld on dry hole marker.
