3/9/22 – MIRU and NU BOP. RIH with bit and scraper and tagged up at 7588', right on bottom perf. 3/10/22 – 3/23/22 - RIH with bit and scraper several times and 7581'. Cut over RBP made 4.5' from 7581'-7585'. Begin to cut over RBP at 7585', made 18'. Begin to cut over RBP, was dragging going down and stacked out about 2' above tag spot. RIH and tagged fish at 7586', attempted to latch on and was able to pull 15k over and would slip off. Tagged and latched onto fish at 7588', jarred it loose and pulled up 23'. RBP stuck. Work on jarring RBP free, got RBP to come free. Recovered RBP.


