Objective: Temporary and abandonment of wellbore.**Safety:**

Comply with all BLM, NMOCD and Operator safety regulations.

All Personnel MUST wear hard hats, steel toed boots, and safety glasses.

No smoking inside rig anchors.

Hold a job safety meeting each morning, and as needed before specific job tasks.

Downhole Work Procedure:

1. HPJSM. Confirm no pressure on wellhead. ND WH, NU 5K manual BOP.
2. MIRU WL lubricators. RIH w/ 7" GR & JB. Contact engineer if ran into tight spots. POOH w/7" GR & JB check for any debris.
3. RIH WL w/7" CIBP and dump bailer. Set plug at 6,250' and dump ~50 sxs cmt over the plug. WOC and tag. POOH and RDMO WL.
4. RIH 2-7/8" tbg, load csg w/2% KCL and biocide. Pressure test csg to 500 psi for 30 minutes. Notify BLM of the results.
5. POOH w/2-7/8" tbg. RDMO
6. Release all associated equipment and clean up location of any trash.
