In order to service depletion, we prioritized development in the Wolfcamp formation delaying the development of the Bone Spring. The simultaneous development and initial production of the two formations would have exceeded infrastructure capacities potentially resulting in the need to flare gas and/or truck oil and water.

EOGs goal is to spud these wells by 9/29/23.
