EOG is actively drilling both the Bone Spring and Wolfcamp formations in our Pegasus development unit. Our strategy in the development of these formations has been to not exceed infrastructure capacities that would result from simultaneous operations between drilling and completion crews. By adopting a strategy of drilling in different stages within the development unit and drilling smaller groups of wells within the unit across a longer period of time, EOG can drill the same wells with less infrastructure and thus less surface disturbance. With this strategy in mind, EOGs goal is to spud these wells by 9/29/23.
