Actual Procedure: Intermediate Casing & Cement / Depths have been adjusted to 26' KB of production rig. 12/11/21: Regulatory agencies given 24 hr notice of BOP & casing PT (Matt Settles 970-985-9972). 12/12 – 12/14: H&P 443 accepted on daywork. NU BOP. PT pre-set 9.625" 36# J55 surface casing 1500 psi for 30 min. Test good & recorded on chart (3rd party Wilson Services). No regulatory agencies onsite to witness. Drill 8.75" hole from 381' to 5702'. KOP 4627'. TOH. 12/15/21: Run 126 jts of 7" 26# P110 LTC casing set from surface to 5692'. Float collar at 5644'. RU to cement. 5000 psi test on lines. Test good. Cement with 55% excess on both lead & tail. Lead: 116 bbls (414 sx) 12.3 ppg, 3.82 yield, 12.71 gps. Tail: 66 bbls (253 sx) 13.5 ppg, 1.47 yield, 7.01 gps. Total cement: 667 sx. Bump plug 1921 psi, pressure up to 2336 psi & hold for 5 min. No cement to surface. Volume calculations indicate top of cement around 1500'. DJR plans to run a CBL to determine actual top.
