Pump 20 bbls fresh water, 40 bbls gel spacer, followed by 695 sks of 13.5 ppg lead and 280 sks of 14.8 ppg tail. Drop plug and displace with 165 bbls brine. 125 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
