**Actual Procedure:** Well spud on 3/18/2022 at 22:00 3/19/2022: Drill 17.5 inch surface hole to 1148 ft. Run 13.37 inch 54.5 lb J-55 surface casing to 1133 ft. Pump 20 bbls fresh water, 40 bbls gel spacer, followed by 695 sks of 13.5 ppg lead and 280 sks of 14.8 ppg tail. Drop plug and displace with 169 bbls brine. 155 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. Surface Casing Details: Casing ran: 3/19/2022, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J-55, Est TOC 0 ft, Depth set 1133 ft, Cement 975 sacks, Yield 1.72 lead/1.34 Tail, Class C.
