Actual Procedure: Dugan Production plugged to abandon the well as per the following procedure from 04/29/2022 to 05/03/2022: 1) RT 4-1/2" casing scraper to 1765'. Tally tubing. RIH w/2-3/8" tubing and set CR @ 1739'. Chacra perforations @ 1790'-1880'. Load casing. 2) Pressure test casing to 600 psi. Casing did not test. Small leak. Run CBL from 1739' to surface. Good cement to surface. Notified and sent copies to BLM/NMOCD. 3) Spot Plug I above CR inside 4-1/2", 10.5# casing from 1739' w/42 sks (48.3 cu ft) Class G neat cement (1.15 cu ft/sk, 5 gal/sk mix water, 15.8#/gal). Displace w/4 bbls water. WOC 4 hrs. TIH w/tubing and tag TOC @ 1230'. Good tag. Plug I, inside 4-1/2" casing, Chacra-PC, 42 sks, 48.3 cu ft, 1230'-1739'. 4) LD tubing to 858'. Load hole. Pressure test casing to 600 psi for 30 mins. Casing tested good. Spot Plug II inside 4-1/2" casing from 858' to 640' w/ 20 sks (23 cu ft) Class G neat cement (1.15 cu ft/sk, 5 gal/sk mix water, 15.8/gal). Displace w/2 bbls water. Plug II, inside 4-1/2" casing, 20 sks, 23 cu ft, Fruitland, 640'-858'. 5) Spot Plug III inside 4-1/2" casing from 522' to surface w/45 sks (52 cu ft) Class G neat cement. No displacement. LD all tubing. WOC overnight. Cut wellhead. Tag TOC @ 51' inside 4-1/2" casing and 10' inside annulus. Top off and install dry hole marker w/20 sks (23 cu ft) Class G cement. Plug III, inside 4-1/2" casing, Surface-Ojo Alamo-Kirtland, 65 sks, 75 cu ft, 0'-522'. 6) Clean location. Well P&A'd 5/3/2022. Gail Clayton w/Farmington BLMFO witnessed job.


