In order to service depletion, EOG prioritized development in the Bone Spring formation delaying the development of the Wolfcamp. The simultaneous development and production of the two formations would have exceeded infrastructure capacities potentially resulting in the need to flare gas and/or truck oil and water. Additionally, recent well results suggest that optimal development of this formation to harvest the most minerals and reduce waste will require supplemental permits.

EOGs goal is to spud this well by 9/1/22.
