OXY USA INC requests approval to add Oxbow CC "17_8" Federal Com #2H to PLC 750-C. This well will be included in a currently approved pools of PIERCE CROSSING; BONESPRING, EAST and PIERCE CROSSING; BONE SPRING and CEDAR CANYON BS and currently approved proposed consolidated leases (CA BS 20-29 W2 T24S R29E) in PLC 750-C.

The facilities described in PLC 750-C are unchanged – each facility has a sales-quality orifice meter (BLM gas FMP or equivalent meter) that continuously measures gas volume before it leaves the facility. Production upstream of the facility gas FMP or equivalent meter is allocated to each well based on well test.

This request is for gas production only. Oil production will be handled through an amendment to PLC-660-B for Salt Flat Battery Train #3 (C-20-24S-29E).


