Procedure Description: DJR submits for approval a request for a well name change from the Gallo Canyon Unit 303H to the LYBROOK M26 2306 303H. This request for a well name change is predicated on the fact that the well's completed interval penetrates lands included within DJRs Gallo Canyon Unit as well as lands not committed to said unit. Due to the fact the dedicated acres for this well combine unit and non-unit lands, the well will be governed by a Communitization Agreement rather than the Gallo Canyon Unit Agreement, which makes it appropriate the well name be changed to the Lybrook M26 2306 303H to adequately reflect this condition.

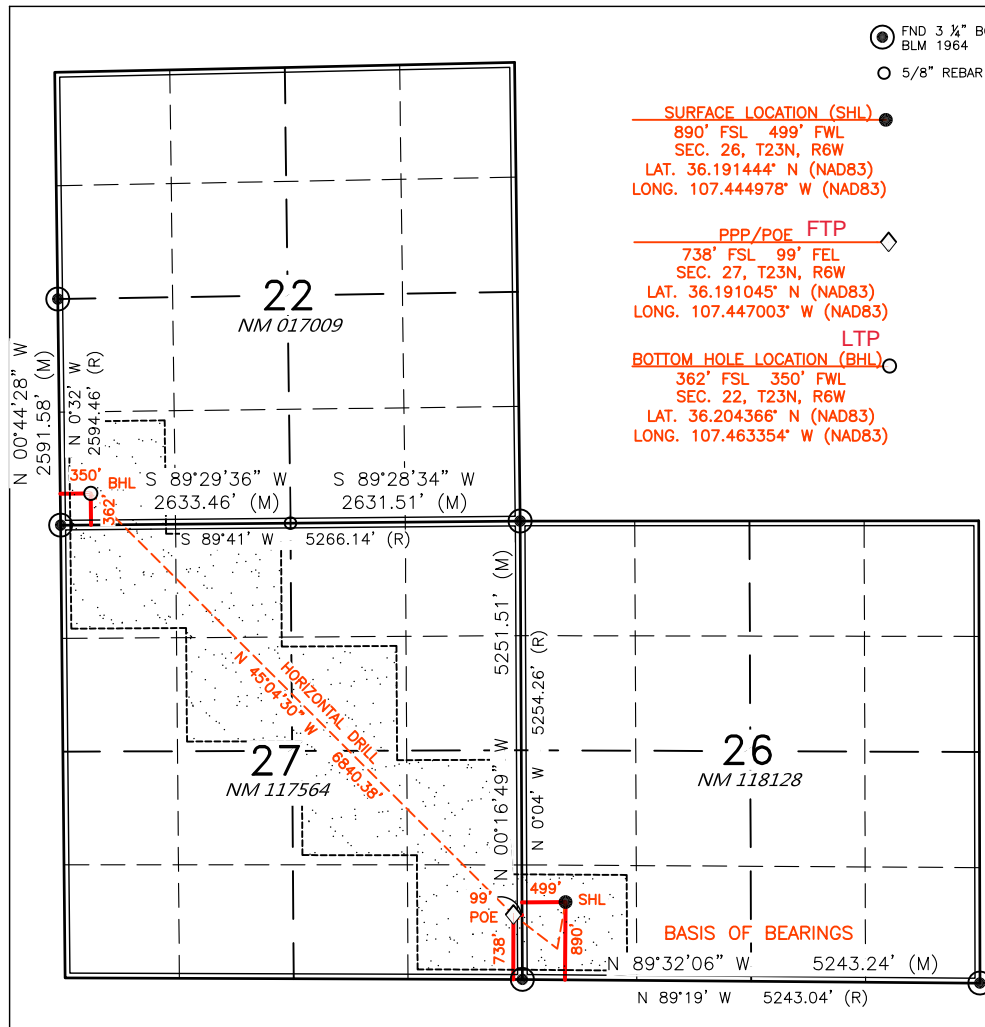

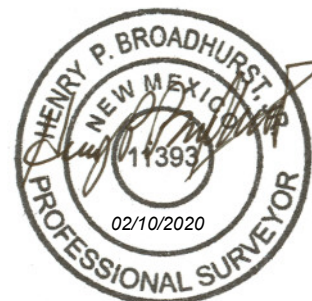
