Pump 20 bbls fresh water, followed by 405 sks of 148 ppg tail cmt. Drop plug and displace with 48 bbls fresh water, 28 bbls brine, 7 bbls fresh water. 42 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
