Pump 20 bbls fresh water, followed by 405 sks of 14.8 ppg tail cmt. Drop plug and displace with 20 bbls fresh water, 20 bbls brine, 4 bbls fresh water. 47 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
