Pump 20 bbls freshwater, followed by 585 sks of 13.5 ppg lead cmt, 340 sks of 14.8 ppg tail cmt. Drop plug and displace with 20 bbls freshwater, 128 bbls brine, 20 bbls freshwater. 130 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
