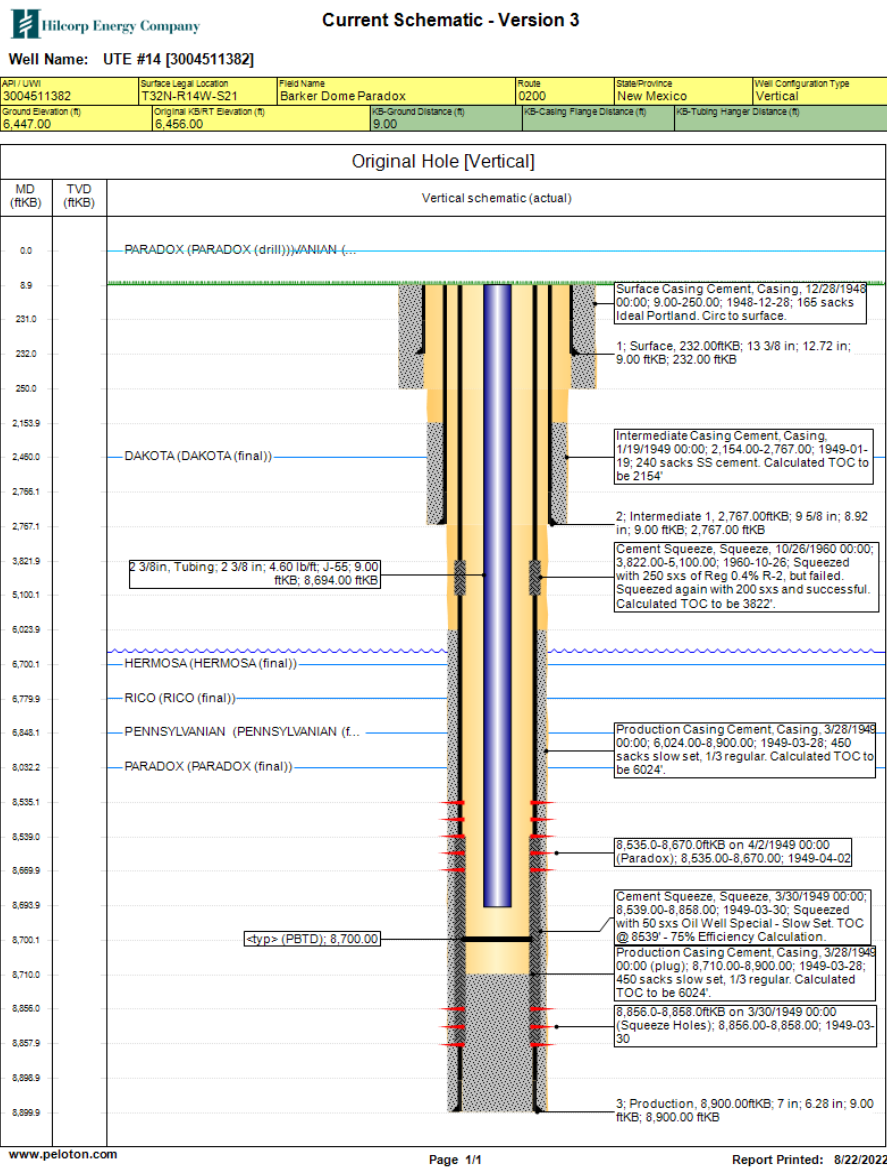

1. Hold pre-job safety meeting. Comply with all **BLM, NMOCD** and HEC safety and environmental regulations. Scope location for base beam. If base beam can not be used, test rig anchors prior to moving in rig.
2. MIRU workover rig. Check casing, tubing, and bradenhead pressures and record them in WellView.
3. RU blow lines from casing valves and begin blowing down casing pressure. Kill well as needed.
4. ND wellhead and NU BOPE. Test and chart BOPs as per regulations. Record pressure test. PU and remove tubing hanger to unland tubing. TOOH with all tubing.
5. TIH w/ bridge plug and set within 50' of top perf (**top perf: 8535'**) at **8485'** or lower.
6. Roll the hole with fluid and test to 560 psi for 30 minutes. Record results. Call NMOCD 24 hours prior to official MIT.
7. Submit MIT results to regulatory. RDMO.

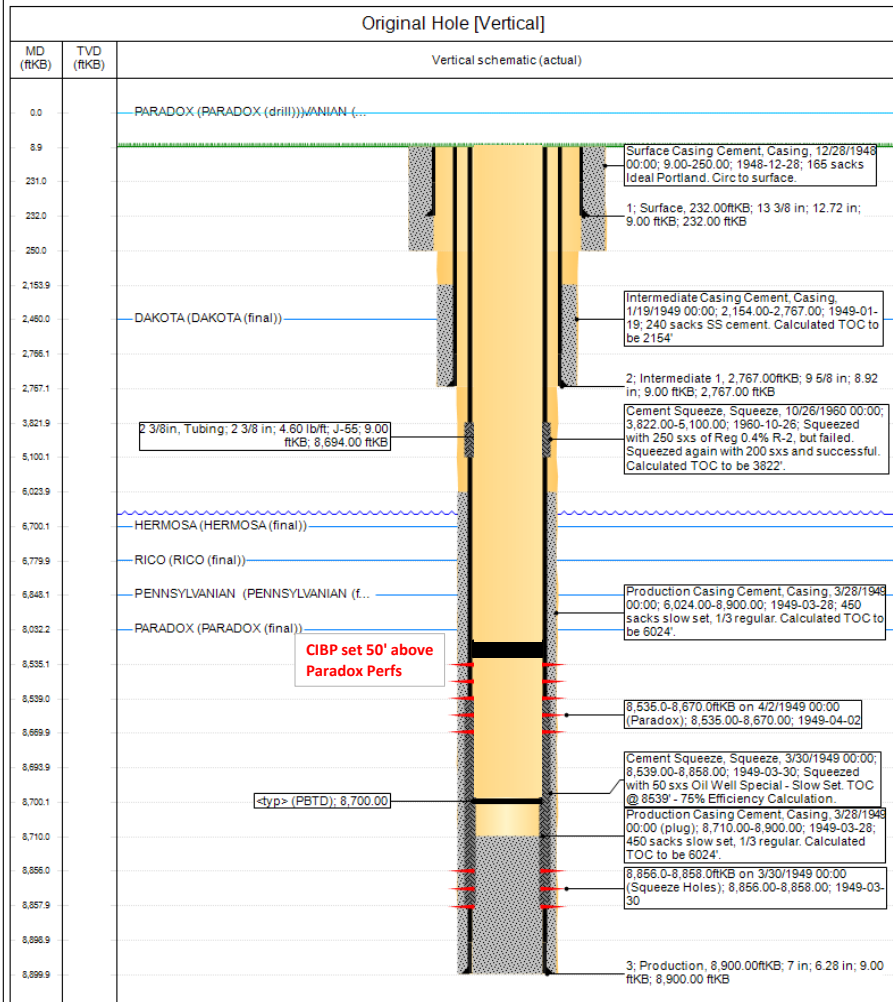
UTE 14 - PROPOSED TA SCHEMATIC

Regarding sundry notices requesting for Temporary Abandoned (TA) status:

The Code of Federal Regulation, 43CFR3162.3-4(a) requires that any well that is not capable of producing in paying quantities must be promptly plugged and abandoned, after approval from BLM.

Therefore, after approval for continued TA status, Operator must exercise one of the following options by August 30, 2023:

1. Establish production, in paying quantities. Paying quantities being defined as: production of oil or gas of sufficient value to exceed direct operating costs and the costs of lease rentals, or minimum royalty, on a sustained basis.
2. Complete plugging operations, utilizing approved Sundry Notice of Intent to Abandon (NOIA) and properly submitted reclamation plans.
3. All previous Conditions of Approval with the original A.P.D remain in effect. information.

Failure to respond to this Written Order is a violation of 43 CFR 3162.1(a) and may result in the issuance of an Incident of Noncompliance and orders to promptly plug and abandon the well listed above.
