Pump 20 bbls fresh water, followed by 810 sks of 13.2 ppg lead cmt, 54 sks of 14.8 ppg tail cmt. Drop plug and displace with 219 bbls of fresh water. 60 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1900 for 30 minutes, good test. 7/17/2022: Drill 8.75 inch production hole to 7845 ft then switch to 7.875 in hole to 15713 ft. 7/24/2022: Run 5.5 inch 20 lb P-110 production casing to 15697 ft MD.
