Well Plan

Drill 14-3/4" hole to ~500' w/ fresh water spud mud. Run 10-3/4" 45.5# J55 BTC casing to TD and cement to surface in one stage.

Drill 9-7/8" x 8-3/4" hole to ~8,550' with cut brine. Run 7-5/8 29.7# P110 BTC x 7-5/8 29.7# P110 W513 to TD and cement to surface in one stage.

Drill 6-3/4" vertical, curve and lateral to ~24,600' with OBM. Run 5.5" 20# P110 TXP-BTC x 5.5" 20# P110 W441 casing from TD to surface and cement to surface in one stage.

Well Control

After setting 10-3/4" casing and installing 5000 psi casing head, NU 13-5/8" Cameron BOP. Test casing to 1500 psi, annular to 2500psi and other BOP equipment to 5000 psi.
