Good afternoon Long,

Citadel 2 left ~60 centralizers in the hole while attempting to run the 7 5/8" casing on the Pure Gold MPD1 29\_17 Fed Com 175H. While running casing we dropped the string. We were able to fish out the casing, however ~60 centralizers were left in the hole. We attempted 4 mill runs without any success.

We will have to sidetrack the original wellbore around the fish to complete the section as per plan.


