9/10/2022: Test BOPS. Drill 12.25 intermediate hole to 5217 ft.

9/11/2022: Run 9.625 inch 40 lb J-55 intermediate casing to 5202 ft. Pump 20 bbls vis water, followed by 790 sks of 11.3 ppg lead cmt, 330 sks of 14.8 ppg tail cmt. Drop plug and displace with 391 bbls fresh water. 70 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

9/11/2022: Drill 8.75 inch production hole to 10881 ft then switch to 7.875 in hole to 16436 ft.

9/17/2022: Run 5.5 inch 20 lb P-110 production casing to 16422 ft MD. Pump 40 bbls fresh water, then 400 sks of 10.5 lead cmt, 1105 sks of 13.2 ppg tail cmt. Drop plug and displace with 20 bbls sugar water and 343 bbls fresh water. 0 bbls returned to surface. Est TOC at 1830 ft.
