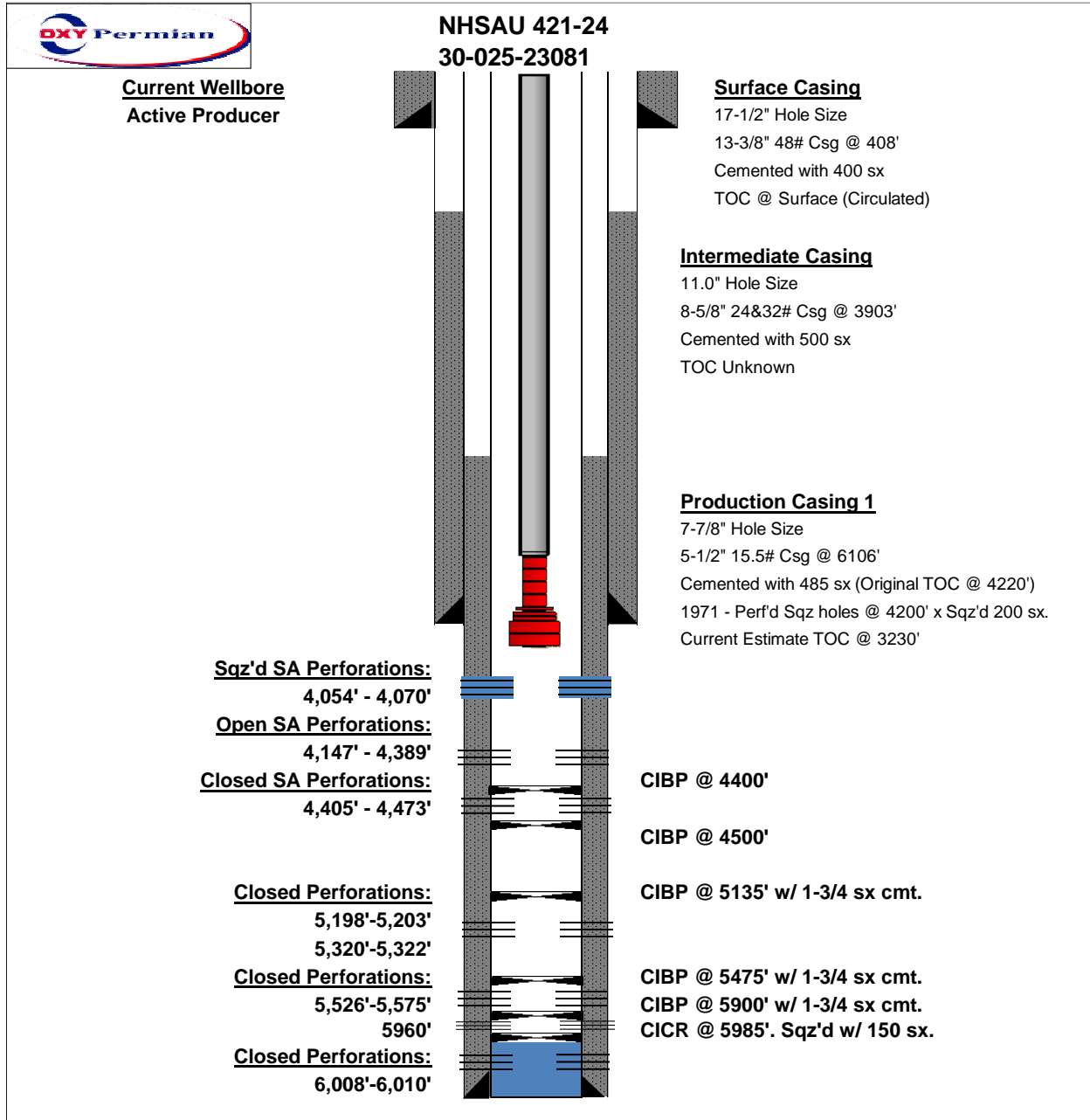

Objective: Plugback lower TZ to reduce gas production.

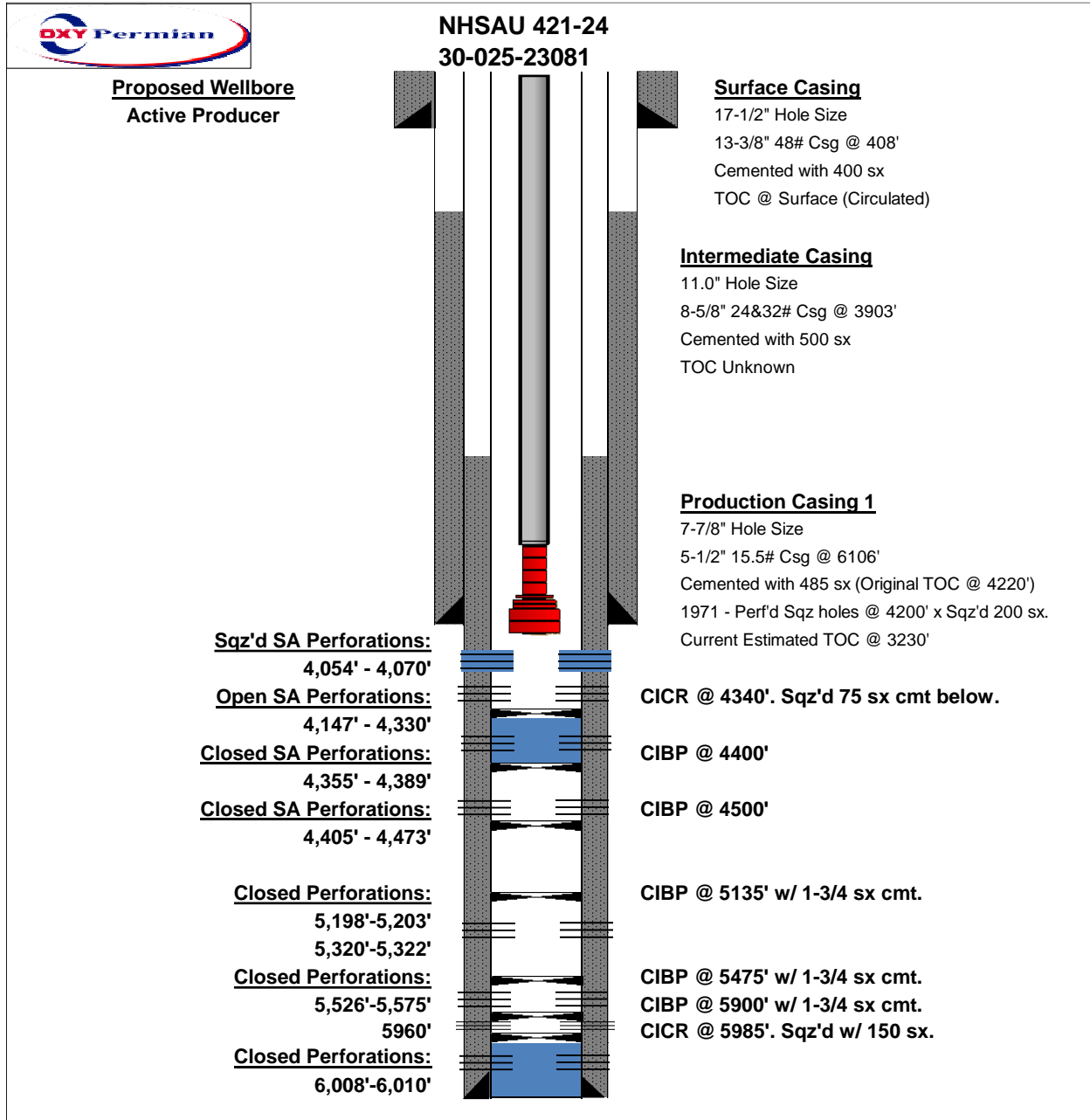
Procedure:

1. MIRU
2. Kill well x ND WH x NU BOP
3. POOH w/ ESP Eqpt
4. RU WL x Set CICR @ ~4340' x RD WL
5. RIH w/ WS & sting into CICR
6. Cement squeeze lower TZ perms w/ 75 sx of cmt
7. Sting out retainer & POOH
8. RIH w/ 4-3/4" bit & CO to new PBTD of 4340'
9. Run Production Eqpt
